DENMORE, JOHN, (Franklin Co.)

Drummer Boy. Enl Mch 1, 1780 in 6th Md Regt in command of Maj Landsell at Prince George's Co, Md. Was in the Battle of Guilford Court House, Camden, Entaw Springs and was wounded in the hand in the service. Br Prince George's Co, Md, 1751. D Nov 28, 1838, Mifflin Twp. Bur Old Cem Mifflin Twp. MI: "John Denmore died Nov 28, 1838, aged 87 years." GM Rev Grave Committee with bronze marker, May 30, 1912. Fur infor Columbus Chap.

DENNIS, JOHN, (Clermont Co.)

DENNY, SAMUEL, (Pickaway Co.)

Actually b. 1767 in Prince Georges County, Maryland, died age 71 DENUNE, JOHN, (Franklin Co.)

Drummer boy and soldier. Enl Mch 1, 1780 in 6th Md Regt in command of Maj Landsell Prince George's Command. Was in the battle of Guilford Court House, Camden, Entaw Springs and Siege of Ninety Six. Was wounded in the hand in the serv. Served until June 1783. Br 1761, France. Mar Sarah Burrell. One child was Alexander Burrell Denune. D Nov 28, 1838, Franklin Co, O. age 77 yrs. Bur Riverside Cem, Mifflin Twp. Sunbury Pike, near Linden Heights, O, in Franklin Co. MI: "John Denune died Nov 28, 1838, aged 77 yrs." GM by descendants and D. A. R. Oct 16, 1927. Was from Prince George Co, Md. His name is on the marble tablet of Rev Soldiers of Franklin Co in Memorial Hall Lobby, Columbus. Was pensioned in 1819 for serv as Pvt in Md Continental Line. DEPOY, CHRISTOPHER, (Ross Co.)

Pvt in Va Line. D Apr 17, 1843. Bur in Concord Twp, Ross Co, O. on Waugh's Hill, west of Austin. MI: name, death and "aged 81 yrs, 7 mos, 19 days." GM Mch 24, 1928. Ref: Pens list. Fur infor Nathaniel Massie Chap.

DEPUE, DANIEL, (Mahoning Co.)

1st Lt Capt Manuel Hover's Company 3rd Bn NJ. Children: Joseph and Margaret. Bur Milton Twp. One of first schoolteachers. Ref: p 184, Vol 2, Hist Trumbull and Mahoning Cos. NJ Officers and Men in Revolution. Fur infor Mahoning Chap.

DEVER, JOHN (DEAVOR), (Scioto Co.)

DEVIN, MICHAEL, (Washington Co.)
